

ORDINANCE C-634-07 (A0108)

AN ORDINANCE AMENDING C-634-07 Section II (B) (1)(2)&(3) RATES TO BE CHARGED FOR WATER SERVICE WITHIN SHANNON CREEK ESTATES ; REPEALING ALL ORDINANCES AND PARTS OF ORDINANCES IN CONFLICT HEREWITH; PROVIDING A REPEALER CLAUSE; AND PROVIDING AN EFFECTIVE DATE CLAUSE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS:

Section I

The water rates within Shannon Creek Estates are set by the Johnson County Special Utility District. These rates are attached as Exhibit "A" and will be placed on the City of Burleson Website, [www.burlesontx.com](http://www.burlesontx.com) . Exhibit "A" will be updated by the Utility Billing Manager and placed in the file as part of the permanent record.

SECTION II

It is hereby declared to be the intention of the City Council that the phrases, clauses, sentences, paragraphs, and sections of this ordinance are severable, and if any phrase, clause, sentence, paragraph, or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph, or section.


SECTION III


