RESOLUTION R-1155-09

A RESOLUTION CANVASSING THE RETURNS OF THE MAY 9, 2009 GENERAL ELECTION OF THREE (3) COUNCIL PLACES FOR FULL TERMS.

WHEREAS, an election was held in Burleson, Texas on May 9, 2009 for the purpose of the election of three councilmembers for full term; and

WHEREAS, the City Council has reviewed all matters pertaining to this election, including ordering, notices, election officers, holding and returns thereof; and

WHEREAS, the City Council hereby canvasses the returns of this election, at which there was submitted to all residents, qualified electors of the City of Burleson for their action thereupon, the election of three (3) councilmembers for full term; and

WHEREAS, the city has diligently inquired into the polling lists and the official election returns which were duly and lawfully made to this Council; the poll lists and the official election returns showing separately the votes cast in the election; and

WHEREAS, from these returns, this Council hereby finds that the following votes were cast in the election by voters who were resident, qualified electors of the City of Burleson; and
