Subject: Ordinance C-594-06 (A0709), adopting the official map of the City of Burleson, declaring said map to be the official boundaries of the corporate limits of the city and its extraterritorial jurisdiction as of the date of adoption. (Final Reading)

Council Action Requested:

Approve Ordinance C-594-06 (A0709), adopting the "Official Map of the City of Burleson" (Final Reading).

Background Information:

Texas Local Government Code 41.001(a) requires each municipality to prepare a map showing the boundaries of the city and its extraterritorial jurisdiction. This ordinance will adopt the official map of the City of Burleson. A copy of the map shall be kept in the office of the City Secretary and the City Engineer. The map reflects all boundary adjustments (annexations and boundary agreements) and our current extraterritorial jurisdiction. This map is based on historic city limit data and annexation and boundary descriptions. Most of the information is not based on a survey performed by a professional land surveyor.

Board/Citizen Input:

The Council approved this ordinance on first reading at its July 6, 2009 meeting.

Financial Considerations:

There is no expenditure of municipal funds associated with this item.

ORDINANCE C-594-06 (A0709)

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF BURLESON, TEXAS, ADOPTING THE OFFICIAL MAP OF THE CITY OF BURLESON, TEXAS; DECLARING SAID MAP TO BE THE OFFICIAL BOUNDARIES OF THE CORPORATE LIMITS OF THE CITY AND ITS EXTRATERRITORIAL JURISDICTION AS OF THE DATE OF THE ADOPTION OF THIS ORDINANCE; AND DECLARING AN EFFECTIVE DATE.

WHEREAS, the City of Burleson, Texas is a home rule city acting under its charter adopted by the electorate pursuant to Article XI, Section 5 of the Texas Constitution and Chapter 9 of the Local Government Code; and

WHEREAS, THE City of Burleson has over a period of years by various ordinances annexed territory from time to time and adjusted its boundaries by agreement with adjacent municipalities; and

WHEREAS, the City Engineer has directed preparation of a map showing the boundaries of the City of Burleson;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF BURLESON:

SECTION 1.

That the map attached hereto as Exhibit "A" and made a part hereof for all purposes is hereby adopted as the "Official Map of the City of Burleson, Texas," reflecting the City's corporate boundaries and extraterritorial jurisdiction as of the date of the passage of this ordinance.

SECTION 2.

That this ordinance shall become effective upon its passage and approval.
