II. General Information and Status Updates

A. Current Case Statistics

As of August 5, the current COVID-19 case statistics for the City of Burleson are as follows:

B. Buy BTX

The Economic Development team launched a new program called "Buy BTX" to help drive consumers back to local businesses. For 3 more weeks, anyone can send a photo of a receipt from any business located within Burleson city limits to BuyBTX@burlesontx.com and be entered into a weekly drawing for a \$50 gift card.

Week eight saw over 500 entries and the seventh round of 10 winners will be announced Friday afternoon.

Anyone can participate, even if you don't live in the city of Burleson. Start turning in those receipts today! Staff will process all entries as they come in and host a live drawing each Friday to select 10 weekly winners. Winners will be contacted and they will receive a \$50 gift card to a local business of their choice. Each receipt will give contestants one entry into the contest and multiple entries can be made each week, but each contestant will only be eligible to win one time per week.

C. New Parks and Recreation Director

The city recently completed its search for a new parks and recreation director. The city worked with Strategic Government Resources during the hiring process. The search resulted in 101 applications, and the city interviewed four impressive finalists. The interview process took place over two days and included a tour of city parks and recreation facility, a virtual meet and greet with the Parks Advisory Board and the Cemetery Board, and three staff interview panels. We are pleased to announce Jen Basham as Burleson's new parks and recreation director. Jen is currently the Parks and Leisure Services Director at the City of Stephenville, Texas. A full professional summary is included below. Jen did a phenomenal job during the interview process, impressing us with her knowledge, approach to the work, and energy. Jen's starting date is September 8.

Jen Basham began her parks and recreation career with the City of Fort Worth, where she served as a Recreation Programmer (2011-2013). She also worked for the City of Keller Parks and Recreation Department as a Recreation Specialist (2013), and Senior

Center Supervisor (2013-2015), and Recreation Manager (2015-2018). Ms. Basham is currently the Parks and Leisure Services Director for the City of Stephenville (2018-Present), where she oversees Parks, Recreation, Aquatics, Seniors, Library, Cemeteries, and Airport. Ms. Basham is a Certified Parks and Recreation Executive (CPRE) and serves as the North Texas Region Director of the Texas Recreation and Parks Society. She also serves as a Site Visitor for the Commission for Accreditation of Parks and Recreation Agencies (CAPRA). Ms. Basham has a Master of Science in Athletic Training from South Dakota State University, and a Bachelor of Science in Health, Physical Education and Recreation from South Dakota State University.
