### **C. Be Healthy Burleson Run canceled**

Due to the COVID-19 pandemic the City of Burleson has made the difficult decision to cancel the Be Healthy Burleson 5k/10k/Fun Walk for 2020. While we had hoped to hold the event, we also felt a responsibility to the health and wellbeing of our event participants, volunteers, event staff, vendors, city partners and spectators, as well as the communities and neighborhoods that

line the course route. Also, the planning, resources, and coordination needed to produce the event would have added constraint on city resources that are already taxed in response to the COVID-19 pandemic. The decision was reached with all of these factors in mind.

As a result, all race registrations will automatically be carried over to the Be Healthy Burleson 5k/10k/Fun Walk for 2021. **D. Emergency Housing and Living Assistance Program**

Since the program began in late August, Harvest House has identified 60 individuals, and 18 households that are potentially eligible to receive assistance totaling \$16,472.74. Verification processes are pending final review.
