
B. Old Town Rundown: Monthly Newsletter

E. Staff Celebrates Halloween



F. Parks Update

The Amazon Prime series "Vindication" will be filming scenes for season two, episode five at Chisenhall Fields Sports Complex this Sunday (Nov. 8) from 3 p.m. to 1 a.m.

Vindication is a faith-based crime drama series filmed predominately in the Burleson and Johnson County area. Season One was released on Amazon Prime in 2019 and has distribution in over 30 countries and has been translated into six languages. It is available nationwide on DVD through various retailers such as Walmart, Target, Best Buy, etc. The season two budget exceeds \$400,000, a significant portion of which will be



spent with small businesses of the host city (location rentals, cast lodging, catering services, etc.).

Season two will bring talent to Texas who starred in the leading roles of faith-based films that grossed over \$100 million at the box office (Overcomer, War Room, Courageous, Unplanned). The scene they will be filming is a flag football fundraiser event that serves as the climax of the 5th episode. It will look much like a normal flag football game. The script requires three plays to be filmed, not an entire game. The cast and film crew will consists of about 30 individuals.

G. BRiCk Staff In-service

The BRiCk will be holding a staff in-service on Sunday, November 15, 2020, from 6:30 pm – 8:30 pm. The purpose of the in-service is to conduct team building and training activities. This is being held at a time outside of the BRiCk’s normal hours, so BRiCk patrons will not be effected. All safety precautions will remain in place such as temperature checks, social distancing, and masks.


