Within five days, the Burleson Police Department arrested a second suspect in the Dec. 19 robbery of Wells Fargo Bank and the shooting of two Burleson Police detectives. Lamarcus Antwon Jones Jr., 22, of Fort Worth, was arrested just before midnight on Wednesday, Dec. 24, on a charge of aggravated robbery. The Christmas Eve arrest was a joint operation involving Burleson Police Department investigators, the STOP Special Crimes Unit, and the Fort Worth Zero Tolerance Unit.

Jones was the driver of a vehicle police believe was involved in the robbery of the Wells Fargo Bank in the 400 block of East Renfro Street in Burleson. Jones was arrested Dec. 24 at his workplace in the 8700 block of West Freeway in Fort Worth. His bond is set at \$500,000. As of the time of this press release, Jones had not been transferred to Johnson County.

Jones is considered an accomplice of Andre Jackson Jr., 19, of Grand Prairie, who is in the Johnson County Law Enforcement Center facing a \$1.5 million bond for two felony charges of aggravated assault on a peace officer with a deadly weapon and one felony charge of aggravated robbery. Jackson was in custody just 15 minutes after the first Dec. 19 call to the Burleson Police Department concerning a suspicious person inside the bank.

Det. David Feucht and Det. Nick Grace were shot by Jackson as Jackson was attempting to flee the scene of the bank robbery. The detectives were transported to John Peter Smith Hospital in Fort Worth by ground ambulance. Grace was treated and released on Dec. 19. Feucht underwent surgery and was released on Dec. 23.

This is an ongoing investigation.

Dec. 22, 2014 - 11:15 a.m.

The Burleson Police Department has identified the suspect in the Dec. 19, 2014, shooting of two detectives and the robbery of Wells Fargo Bank as Andre Jackson Jr., 19, of Grand Prairie. Three charges have been filed against

Jackson, including two felony charges of aggravated assault on a peace officer with a deadly weapon and one felony charge of aggravated robbery. Jackson has been transferred to the Johnson County Law Enforcement Center. Jackson's bond is \$1.5 million (\$500,000 on each charge). The Johnson County District Attorney's Office will prosecute the case.

This is an ongoing investigation. Burleson Police are still looking in to possible accomplices as well as connections to other bank robberies.

UPDATE, 9:15 p.m., Dec. 19, 2014

The detectives who were shot as they were attempting to apprehend a bank robber on Dec. 19 have been identified.

Det. David Feucht is a 23-year veteran of the Burleson Police Department who has 27 years total law enforcement experience. Det. Nick Grace has been with Burleson for 10 years and has 14 years total law enforcement experience. Det. Grace was treated and released Dec. 19. Det. Feucht is still in stable condition at John Peter Smith Hospital in Fort Worth.

Dec. 19, 2014, 6:15 p.m.

Burleson's dispatch received a suspicious person call, which became a bank robbery, Friday afternoon. Two Burleson police detectives were shot while attempting to apprehend the suspect who robbed a Wells Fargo Bank in Burleson. One detective sustained minor injuries and was treated and released. The second detective has undergone surgery and is presently in stable condition at John Peter Smith Hospital in Fort Worth.

DATE/TIME: Friday, Dec. 19, 12:07 p.m.

PLACE: Wells Fargo Bank, 400 block East Renfro Street, Burleson

SUSPECT: Taken into custody at 12:22 p.m., Dec. 19

Patrol officers responded. Detectives were in the area and responded to assist patrol. The suspect handed the teller a note, then left the bank with an undisclosed amount of money.

The suspect exited the bank on foot, walked past another business, and then was approached by the plainclothes detectives in the area of the 7-11 on Renfro Street. The detective identified himself as a police officer and gave the suspect verbal commands to stop. The suspect failed to comply, then the suspect fired a gun at the detectives, striking both of them. At least one officer returned fire as the suspect fled on foot.

The suspect entered the 7-11, with patrol officers following behind. Officers took the suspect into custody without incident. A semi-automatic handgun and an undisclosed amount of money were recovered at the crime scene.

The detectives were transported by ground ambulance to the hospital. Medical personnel on scene checked the suspect. The suspect did not appear to have any visible signs of injury, and he refused medical treatment.

The FBI is involved in the investigation. The suspect's name is not being released at this time. The suspect could faces charges of aggravated robbery and two counts of aggravated assault of a police officer, all felony charges.

The names of the detectives who were shot are not being released at this time to give their families privacy.
