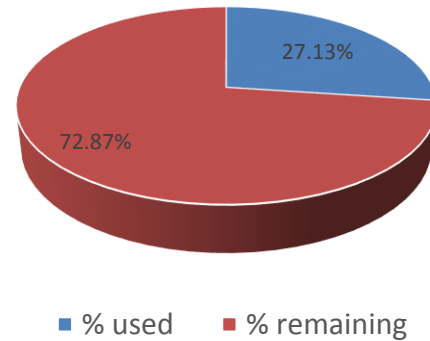

Total mosquitoes trapped for 2018 season – 36474

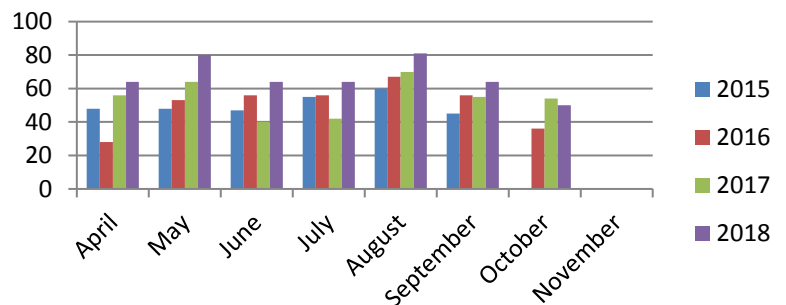
Total spray missions for season – 7

Trapping will resume in April 2019

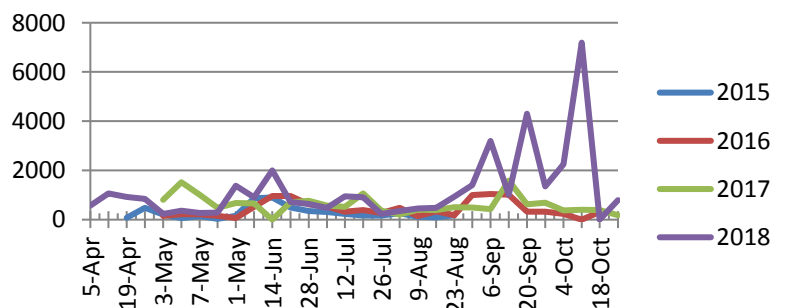

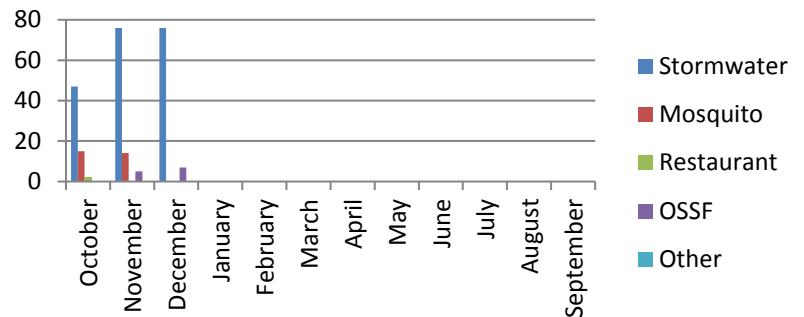
