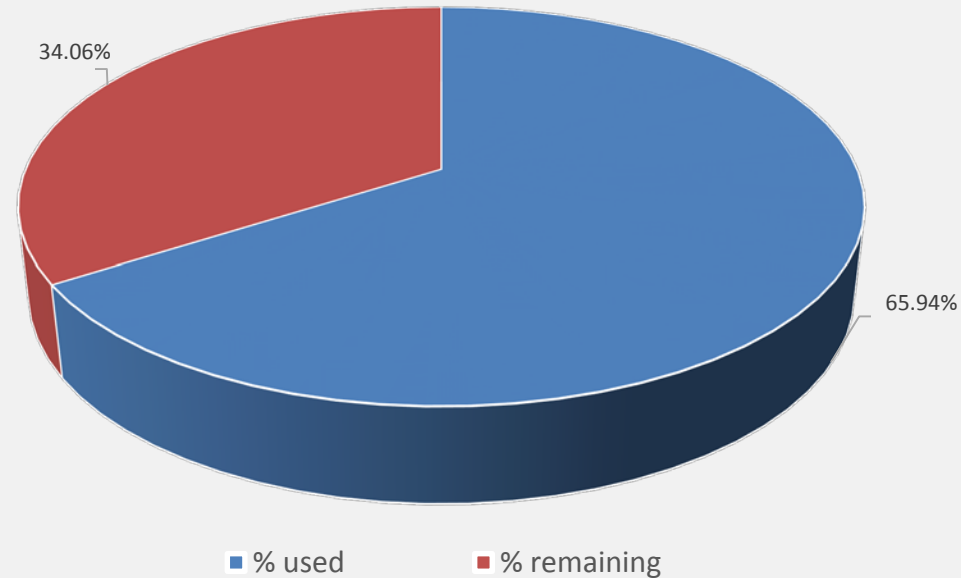

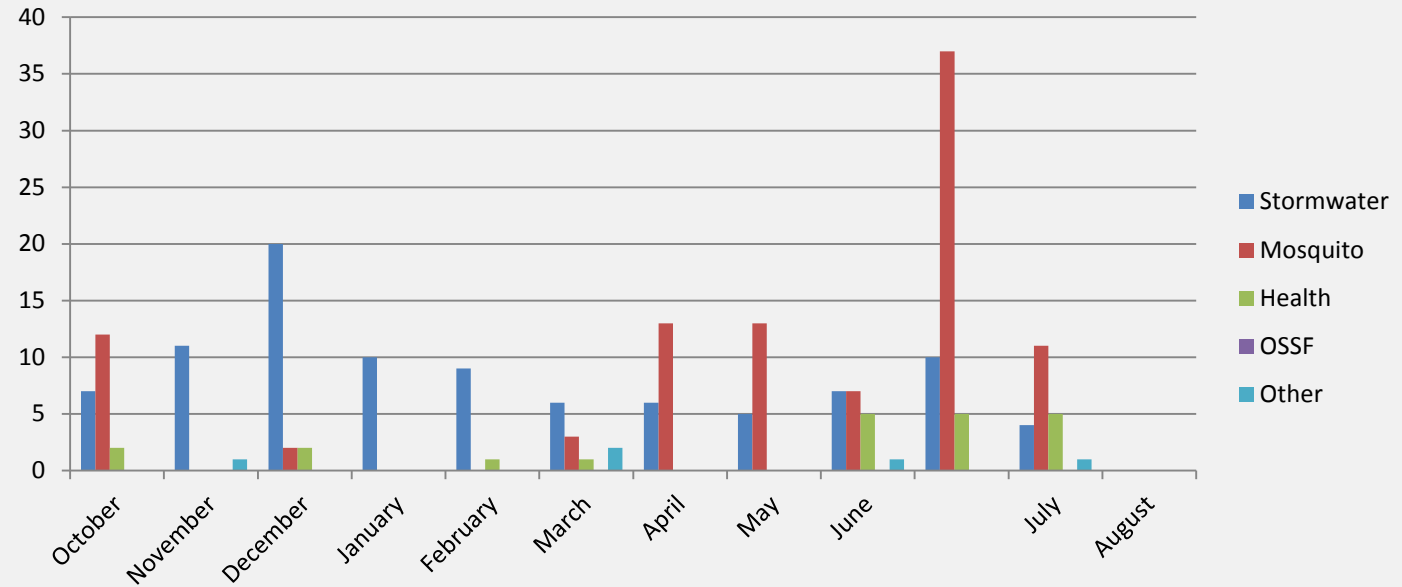

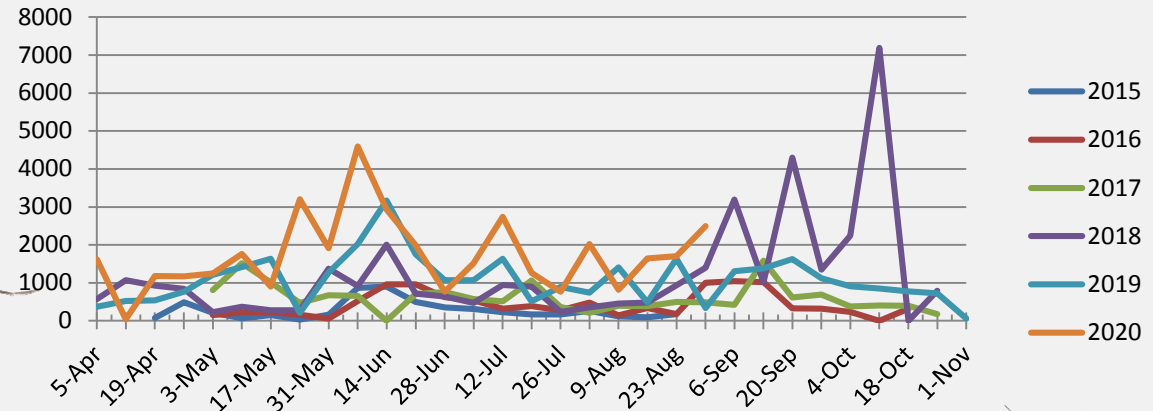

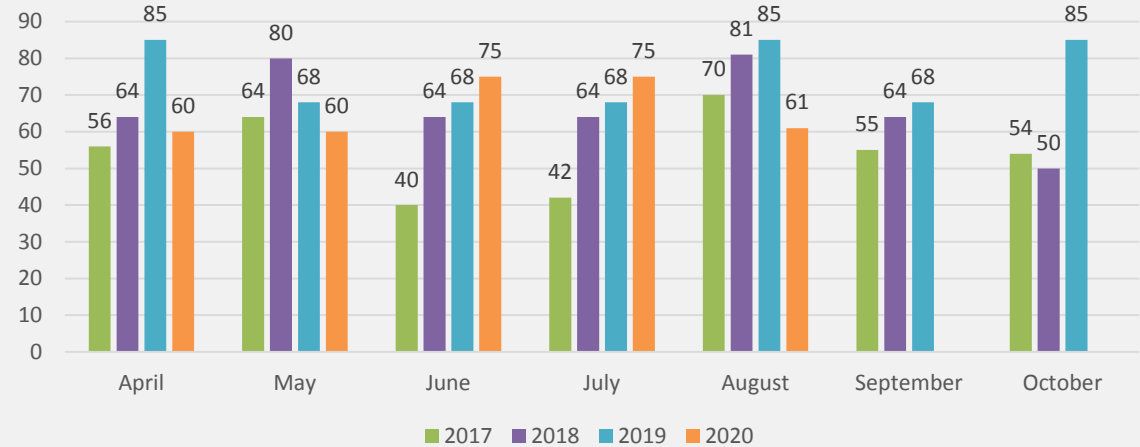

Health Inspections

The City of Burleson Environmental Services Division is now responsible for conducting health inspections of food facilities and public/semi-public swimming pools and spas. This also includes permitting, taking payments, and complaint investigations.

This includes regulation of restaurants, groceries, daycare kitchens temporary food events, mobile food vendors, and, public and semi-public pools, spas and interactive water features.

HEALTH INSPECTIONS

Inspection scores explained

Food facilities are scored on demerit system for full inspections.

A score of 0 is essentially perfect while a score of 30 or more is considered failing.

Failing score will require a timely follow-up to ensure corrections are made.

Complaints, follow-ups, temporary or preoperational inspections may be unscored due to the fact that they could be solely addressing specific issues.

Pools/spas and interactive water features are inspected on pass/fail basis. Where life safety is at risk a failure is noted and the facility is closed until a follow-up and correction is made.
