

# DAYCARE/GROUP POOL RESERVATION POLICY

**\*Reservations are required to guarantee group usage of the indoor or outdoor pool (2 hour limit)\***

- **OUTDOOR POOL**  
\$100.00 for 30 people - Minimum fee  
Additional persons \$3.00 each
- **INDOOR POOL**  
\$150.00 for 30 people - Minimum fee  
Additional persons \$5.00 each

The minimum fee is the same for all group reservations regardless of daycare/business location. This fee must be paid in full at the time that the reservation is made. Payment of minimum fee guarantees your reservation and is nonrefundable. Groups must check in at the BRiCk membership desk on the day of the reservation. Fees for additional persons will be determined by headcount and collected at this time.

In the event of severe weather, we will do our best to accommodate your group by allowing usage of the indoor pool at no additional cost. However, this is not a guarantee due to staffing and number of persons already using the indoor pool. You may reschedule for a future date if accommodations cannot be made on the day of your reservation.

Groups without a reservation are accommodated on a first come first serve basis. It is highly recommended to call the BRiCk before travelling to the center to check **probability** (not a guarantee) of usage. Groups without prior reservations will not be allowed access if the pools are already at or near capacity. Groups without reservations will be subject to standard day pass rates.

## Daycare Pool Reservation Form

Daycares and large groups who would like to visit our facility can make reservations at the BRiCK. Designation of Daycare Slots operate on a “first come, first serve” reservation basis. The maximum size of a group is 50 children with the appropriate number of adult supervisors. If you have a group of more than 50 visitors, you must have approval from aquatic supervisor.

### **OUTDOOR POOL VISITATION (Children ages 5 and up)**

**COST:** \$100.00 minimum fee; covers 30 people  
 Additional Persons \$3.00 each

Swimming Area depth 3.5 ft to 7 ft., Diving board area depth 13 ft., Diving area depth 7ft to 13 ft., Picnic Area, Boy’s and Girl’s Bathrooms, Vending Machines

*Children under the age of 5 are not allowed to be brought to the outdoor facility by daycares because the shallowest depth of the pool is 3.5 ft, which is too deep for most little ones- the chances of drowning are significantly higher and it is not very fun for them to just sit on the steps. If you’re looking to bring little ones in, visit the Indoor Pool, where there is a play structure area and zero depth entry.*

### **INDOOR POOL VISITATION (All Ages)**

**COST:** \$150.00 minimum fee; covers 30 people  
 Additional Persons \$5.00 each

Play Structure, Lazy River, Vortex, Lap Pool, Waterpark Slide, Deck Area, Sun Deck  
 Waterpark Slide height requirement: 48” tall to ride.

### **SUPERVISION:**

**Groups must provide one adult (eighteen years of age or older) per four (4) children under the age of seven (1 :4 <7 years).** Adult supervisors must **accompany all children**, under the age of seven, **in the water at all times.**

**Groups must provide one adult (eighteen years of age or older) per eight (8) children ages eight and older (1:8 >8 years).** Adult supervisors must **directly supervise** all children, ages eight and older, either from the **pool deck or in the water at all times.**

**NOTE: These ratios MUST be maintained or admission will be denied.**

**BREAK TIME:** The last ten minutes of every hour is “break time”, which means everyone under the age of 18 years old must exit the pool for the full ten minutes, until all guards are on stand and blow the enter

whistle. This rule is in place to encourage children to take time to use the restroom, apply more sun block, rehydrate and eat a snack if desired, in the appropriate areas. "Break time" really cuts down on the amount of excrement accidents, as it affords children the opportunity to take a bathroom break before it is too late. Your cooperation and support of this rule is appreciated and encouraged, as the results are a win-win for everyone!

**DAYCARE RULES (In addition to facility rules)**

1. Each Daycare group is required and responsible for implementing a system of their choice to readily and effectively identify the children in their group (wearing matching colored t-shirts, arm bands, etc.) and notify lead guard of that system before visiting the facility.
2. All adult supervisors must be wearing a swimsuit and be directly supervising, in the water or from the deck at all times.
3. The adult supervisors sent to supervise the Group are responsible for their children's conduct and for taking the appropriate disciplinary action(s).
4. Groups must adhere to the facility rules, regulations and staff requests. Violations can result in Group dismissal.
5. No loitering in the lobby or member areas.
6. Groups must have transportation on site and ready for immediate exit from the facility, if necessary.
7. The City of Burleson reserves the right to deny Group admission or void this agreement at any time.
