The Type B Board of Directors may conduct private consultations with its attorneys when the Board seeks the advice of its attorney concerning any item on this agenda, or in which the duty of the attorney to the Board under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Government Code. This consultation includes, but is not limited to, the following:
2. Pursuant to Sec. 551.072, to discuss or deliberate regarding matters concerning real property.
3. Pursuant to Sec. 551.087, to discuss or deliberate regarding commercial or financial information that the governmental body has received from a business prospect that the governmental body seeks to have locate, stay, or expand in or near the territory of the governmental body and with which the governmental body is conducting economic development negotiations or to deliberate the offer of a financial or other incentive to said business prospect.
