LEAP Guidelines

ONLY residents, community groups, or businesses in the City of Burleson may borrow the tools from the Tool Shed. Upon completing an application, showing proof of residency and signing a waiver of liability form, tools may be signed out from LEAP.

- Borrower must pick up and return tools on Monday - Friday between the hours of 8:00 AM - 5:00 PM.
- Borrower must return tools to the City of Burleson Service Center, 725 S.E. John Jones Drive, within 72 hours of the time they are borrowed.
- Borrower must clean tools and return them in the condition in which they were borrowed. Equipment/tools returned in an unclean or broken condition may result in the user not being allowed to borrow equipment/tools in the future.
- Borrower is responsible for any injury to self or damage to his/her property or the property of others occurring from the use of the equipment/tools.
- Borrower is responsible for the use of equipment/tools by others/third party.
- Borrower shall ensure all power equipment/tools are only used by individuals 18 years of age or older.
- Power tools that require fuel (gas and oil mixture) will be loaned with an accompanying fuel can. Borrower is required to purchase their own gas and/or oil in accordance with the instructions and user manual for the tool/equipment.

L.E.A.P

AGREEMENT INCLUDING RELEASE AND IDEMNIFICATION

WHEREAS, the City of Burleson Texas (hereinafter referred to as "CITY") consents and agrees to permit the undersigned (hereinafter referred to as "BORROWER"), to participate in the CITY's LAWN EQUIPMENT ASSISTANCE PROGRAM (hereinafter referred to as ("L.E.A.P")), subject to the adherence of the BORROWER to any provision set out in the rules and regulations of the City of Burleson Texas or the Neighborhood Services Department.

NOW, THEREFORE, for and in consideration of the premises and the mutual promises, covenants, and agreements set forth in this Agreement, the CITY and BORROWERS agree that the CITY, its agents or employees, shall not be liable or responsible for, and shall be SAVED, HELD HARMLESS, RELEASED and IDEMNIFIED by BORROWER from and against any and all suits, actions, losses, damages, claims, or liability of any character, type, or description, including but not limited to all expenses of litigation, court costs, and attorney fees for injury or death to any person, or injury to any property received or sustained by any person or persons or property arising out of, or occasioned by, directly or indirectly, the participation of BORROWER, in L.E.A.P, including claims and damages arising in whole or in part from the negligence of the CITY, its agents or employees.

IT IS THE EXPRESS INTENT OF THE PARTIES TO THIS AGREEMENT THAT THE INDEMNITY PROVIDED FOR IN THE AGREEMENT IS AN INDEMNITY EXTENDED BY BORROWER TO INDEMNIFY AND PROTECT THE CITY FROM ANY AND ALL CLAIMS OR ACTIONS, AS SET FORTH ABOVE, OR ANY KIND, ARISING DIRECTLY OR INDIRECTLY FROM THE PARTICIPATION OF BORROWER IN THE LAWN EQUIPMENT ASSISTANCE PROGRAM REGARDLESS OF WHETHER SUCH CLAIMS OR ACTIONS ARE FOUNDED IN WHOLE OR IN PART UPON ALLEGED NEGLIGENCE OF CITY, ITS REPRESENTATIVES, AGENTS OR EMPLOYEES. BORROWER acknowledges that he/she is solely responsible for any negligence or liability incurred as a result of his/her voluntary participation in LEAP and BORROWER's activities which may include: using power tools or equipment provided by either CITY or BORROWER; cleaning or clearing lots or property of garbage, refuse and debris. BORROWER acknowledges that the activities undertaken may require climbing ladders, handling chemicals and lifting heavy objects and BORROWER attests that he/she is physically able to perform these actions.

It is further understood and agreed that the BORROWER will participate solely as an individual on a voluntary basis and not as an employee, contractor or agent of the CITY or its agents or employees. Individuals who are employed by the CITY acknowledge that their participation in L.E.A.P is outside the scope of their employment and is performed on a voluntary basis only. BORROWER is responsible for their own transportation.

In making the Agreement, BORROWER relies wholly upon his/her own judgment belief and knowledge and has not been influenced to any extent whatsoever by any representations or statements not continued in the Agreement.
