Whatisafalsealarm?

A false alarm is any alarm caused by human error or equipment problems requiring police or fire department response, with no evidence of an actual crime, fire or medical incident.

Causes of false alarms...

- Failure to train other authorized users.
- Use of incorrect keypad codes.
- Failure to secure doors and windows properly before turning the alarm system on.
- Failure to notify monitoring facility of unscheduled openings or closings.
- Improper application or installation of interior motion detectors.
- Improper application or installation of outdoor beams.
- Improper charging or maintenance of batteries.
- Changes in the environment (i.e. new animals, design changes, seasonal decorations, and plants).
- Faulty equipment (i.e. panel detectors, keypads, sensors etc.)

<u>WHAT GAN YOU DO TO REDUCE</u> FAUSE AUARMS?

- Remove all cobwebs and dirt from around motion detectors and smoke detectors.
- Replace the backup battery every 3-5 years.
- Notify your alarm company immediately if you think your alarm system isn't working properly.
- Make sure that *anyone* with a key to the premise is an authorized user.
- Make sure everyone authorized to use your system is familiar with its operations and who to call in case of an accidental false alarm.
- Have your alarm company check and service your system regularly.
- Secure doors and windows before turning on system.
- Notify your alarm company of any and all changes (i.e. houseguests, name changes, new employees, termination of employees, etc.)
- Rehearse alarm cancellation with *anyone* who uses your system.
- Keep your security system instruction book, alarm company's name and phone number handy.
- Know your pass code/pin number
- Cancel all alarms that don't need emergency response

<u>Mhattodoffyouraecidently</u> setoffyouralarm:

First: Don't Panic. Carefully enter your disarm code to reset your system.

Second: Wait for your alarm company to call and ask you for a password or ID number.

Third: Do not leave your home or business until you have talked with your alarm monitoring station! If they don't call you, call them to cancel the alarm dispatch.

Do not call 911 to cancel an alarm- You must call your alarm monitoring station.
